A presidential campaign that has careened through a felony trial, an incumbent President being pushed off the ticket and multiple assassination attempts comes down to a final push across a handful of states on the eve of Election Day. Kamala Harris will spend all of Monday in Pennsylvania, whose 19 electoral votes offer the largest prize among the states expected to determine the Electoral College outcome. The vice-president and Democratic nominee will visit workingclass areas including Allentown and end with a late-night Philadelphia rally that includes Lady Gaga and Oprah Winfrey.

Donald Trump plans

four rallies in three states, beginning in Raleigh, North Carolina and stopping twice in Pennsylvania with events in Reading and Pittsburgh. The Republican nominee and former President ends his campaign the way he ended the first two, with a and the first two, with a late Monday night event in Grand Rapids, Michigan. About 77 million Americans already have voted early, but Harris and Trump are pushing to turn out many millions more supporters, on Tuesday. supporters on Tuesday. Either result on Election Day will yield a historic out-



incoming President to have been indicted and convicted of a felony, after his hushmoney trial in New York. He will gain the power to end other federal investigations pending against him. Trump would also become the second President in history to win non-consecutive White House terms, after Grover Cleveland in the late 19th century. Harris is vying to become the first woman, first Black woman and first person of South Asian descent to reach the Oval Office, four years after she broke the same barriers in national office by becoming President Joe Biden's second-in-command. Harris, 60, has played down the historic nature of her candidacy, which materialised only after the 81year-old President ended his re-election bid after his June debate against the 78-year-old Trump accentuated questions about Biden's age. Instead, Harris has pitched come. A Trump victory ticket after Biden's disas-would make him the first trous performance in a June change, emphasised her

support for abortion rights after the Supreme Court's 2022 decision ending the constitutional right to abortion services, and regularly noted the former President's role in the January 6 attack on the US Capitol Assembling a coalition ranging from progressives like Rep. Alexandria Ocasio-Cortez of New York to Republican former vice-president Dick Cheney, Harris has called Trump a threat to democracy and late in the campaign even embraced the critique that Trump is accurately described as a "fascist". Heading into Monday, Harris has mostly stopped mentioning Trump. She is promising to solve prob-lems and seek consensus, while sounding an almost

exclusively optimistic tone reminiscent of her campaign's opening days when she embraced "the politics of joy" and the campaign theme "Freedom".

"From the very start, our campaign has not been about being against something, it is about being for something," Harris said on Sunday evening at Michigan State University. Trump, renewing his "Make America Great Again" and "America First" slogans, has made his hard-line approach to immigration and withering criticisms of Harris and Biden the anchors of his argument for a second administration. He's hammered Democrats for an inflationary economy, and he's pledged to lead an economic "golden age", end international conflicts and seal the US southern border. But Trump also has veered often into grievances over being prosecuted after trying to overturn Biden's victory and repeatedly denigrated the country he wants to lead again as a "failed nation". As recently as Sunday, he renewed his false claims that US elections are rigged against him, mused about violence against journalists and said he "shouldn't have left" the White House in 2021 dark turns that have overshadowed another anchor of his closing argument "Kamala broke it. I will fix it."

US presidential elections: Washington experiences calm before the storm

Washington, D.C. was not up to its usual hustle and bustle on Monday, the day before Americans head to the polls to elect a new president on November 5. Traffic seemed just a little bit lighter, with fewer people out and about. "The city is quiet, so quiet," said Manaye, an elderly Uber driver, on Monday. He didn't sound happy, and it soon became clear why. "I guess everyone is watching the election from home" he election from home," he complained. Not a lot of business to be had for Uber drivers. Some buildings along Pennsylvania Avenue, the street that the White House is on, started safety preparations as early as Friday, with workers barricading the street-fronts with plywood Office buildings as well as convenience restaurants are taking pre-cautions. "There definitely always are fears living around D.C. that something like the Capitol riots might happen again, that it might get violent around here," a young woman walking along the fencing protecting the White House said. "But overall, I think people will be ok." Washington is on high alert ahead of the November 5 election because the memory of the



last transfer of power is still fresh in people's minds. On January 6, 2021, when Congress certified Joe Biden's election victory, an angry mob of Donald Trump supporters and rightwing extremists stormed the US Capitol Half a year before that, during the Black Lives Matter

protests in May and June 2020, several street-front businesses in Washington's downtown area were damaged. City officials as well as local and federal agencies have vowed not to be caught off-guard this time around and to keep everyone safe through election week and beyond.

Federal agencies say Russia and Iran are ramping up influence campaigns targeting voters

WASHINGTON (AGENCY)

The nation's federal law enforcement and election security agencies are debunking two new examples of Russian election disinformation on the eve of Election Day, highlighting attempts by foreign actors to sow doubt in the U.S. voting process and warning that the efforts run the risk of inciting violence against election officials. In a joint statement late Monday, federal officials pointed to a recent article posted by Russian actors falsely claiming that U.S. officials across presidential swing states were orchestrating a plan to commit fraud, as well as a video that falsely depicted an interview with an individual claiming election fraud in Arizona.

U.S. intelligence reveals that Russia-linked influence actors "are manufacturing videos and creating fake articles to undermine the legitimacy of the election, instill fear in voters regarding the election process, and suggest Americans are

Podcaster Ioe Rogan endorses Trump for president

WASHINGTON (AGENCY) Popular podcaster Joe Rogan, who recently interviewed Republican presidential candidate Donald Trump for nearly three hours, said on Monday he has endorsed the former president in the race to the White House. Trump faces Democratic Vice President Kamala Harris in the Nov. 5 U.S. election in what polls show to be a tight race. Harris has got multiple celebrity endorsements. "For the record, yes, that's an endorsement of Trump," Rogan said on X while posting a clip of his interview with billionaire Elon Musk, who has also endorsed Trump. Rogan said in his post that Musk made the "most compelling case for Trump." Trump's recent interview with Rogan lasted about 3 hours and was released on YouTube and Spotify in late October. The two discussed a range of topics and the interview got

हरियाणा में पराली जलाने की घटनाओं में आई गिरावट : श्याम सिंह राणा

चंडीगढ़। हरियाणा के कृषि एवं किसान कल्याण मंत्री श्री श्याम सिंह राणा ने बताया कि राज्य सरकार द्वारा किसानों को पराली को खेत में मिलाकर खाद के रूप में उपयोग करने के लिए प्रेरित किया जा रहा है, जिससे न केवल भूमि की उर्वरता में वृद्धि हो रही है बल्कि किसानों के लिए आर्थिक लाभ भी सुनिश्चित हो रहे हैं। श्री राणा ने कहा कि फसल अवशेष को खेत में मिलाने से मुदा में कार्बन और अन्य पोषक तत्वों की मात्रा बढ जाती है, जिससे अगली फसलों की पैदावार में भी वृद्धि होती है। उन्होंने कहा, 'वैज्ञानिक अनुसंधान से साबित हुआ है कि खेत में पराली मिलाने से मृदा का पोषक चक्र मजबूत होता है और मृदा कार्बन का स्तर बढ़ता है, जिससे अगले फसलों की उपज में भी सुधार होता है।'

उन्होंने बताया कि कई प्रगतिशील किसान अब फसल अवशेषों को मिट्टी में मिलाकर उर्वरक के रूप में उपयोग कर रहे हैं। इस प्रक्रिया से न केवल प्रति वर्ष 3 से 5 क्विंटल प्रति एकड फसल की पैदावार में वृद्धि हो रही



है, बल्कि यूरिया की खपत भी कम हो कर लागत में कटौती हो रही है। यमुनानगर जिले के बकाना गांव के किसान राजेश सैनी का उदाहरण देते हुए कृषि मंत्री ने कहा कि उन्होंने पिछले तीन वर्षों से पराली को जलाने की बजाए खेत की मिट्टी में मिलाया है, जिससे उनकी फसल की पैदावार लगभग छह क्रिटल प्रति एकड बढ गई है। इस तरीके से उनकी प्रति एकड वार्षिक आय में 10,000 से 15,000 रुपये तक का इजाफा हुआ है। कृषि एवं

किसान कल्याण मंत्री ने बताया कि हरियाणा में लगभग 28 लाख एकड़ भूमि पर धान की खेती होती है। इस साल राज्य सरकार द्वारा किसानों में जागरूकता फैलाने के लिए चलाई गई मुहिम का नतीजा है कि पराली जलाने की

घटनाओं में उल्लेखनीय कमी आई है। राज्य सरकार ने इन-सीटू और एक्स-सीटू प्रबंधन के लिए किसानों को सब्सिडी पर मशीनें उपलब्ध कराई हैं और जो किसान पराली नहीं जलाते हैं, उन्हें सरकार की ओर से - कहा ,पराली को खाद में बदलकर उपज और मुनाफे में बढ़ोतरी

प्रति एकड़ 1,000 रुपये की आर्थिक सहायता दी जा रही है। श्री श्याम सिंह राणा ने यह भी कहा कि हरियाणा सरकार के इन प्रयासों की सराहना सुप्रीम कोर्ट ने भी की है और यह हरियाणा ही है जो किसानों को इस तरह की सह्लियतें प्रदान कर रहा है। साथ ही, उन्होंने दिल्ली में बढते प्रदुषण के लिए पराली जलाने को एकमात्र कारण मानने को गलत बताया।
